**Predvideni študijski rezultati:**

Znanje in razumevanje:

Študent/študentka:

- pozna osnovne značilnosti različnih političnih sistemov in procese njihovega razvoja
- pozna značilnosti slovenskega političnega sistema, teoretično osnovo delitve oblasti ter sistem delitve oblasti v slovenskem političnem sistemu
- razlikuje med različnimi volilnimi sistemi, ter pozna njihove značilnosti;
- pozna pristojnosti in razmerja med posameznimi deli političnega sistema
- pozna osnovna načela delovanja EU oz. razmerja med nacionalno državo in EU
- pozna načelo subsidiarnosti v kontekstu EU povezovanja
- je usposobljen za samostojno kritično vrednotenje in analiziranje različnih političnih sistemov in vrednotenje njihovih delov
- razume koncept javnih politik in razlikuje med *politics*, *polity* in *public policy*
- pozna značilnosti posameznih faz procesa oblikovanja in izvajanja javnih politik (*policy procesa*)

**Intended learning outcomes:**

Student:

- knows basics of Slovenian political system, theoretical basics of separation of powers within the Slovenian political system
- understands different electoral systems and knows differences among them
- knows competences and relations between main actors in political system
- knows basics of the EU and relations between national states and EU
- knows principle of subsidiarity within the EU
- is capable of independent and critical evaluation and analysis of different political systems and assessment of their institutions
- understands the concept of public policies and differentiates between policy, polity and politics
- knows policy process and policy cycle phases
- is capable of using basic policy methods
